Glenn is a highly experienced independent arbitrator and mediator. He practiced as a litigator for forty years, acting as an arbitrator alongside his counsel work for much of that time. He now works full-time as an arbitrator, sitting nationwide and globally, with offices in Atlanta and London.

Peers and users familiar with Glenn's work as an arbitrator describe him as "very diligent and pragmatic, thorough, and extremely professional," as doing "an excellent job of conducting proceedings in an efficient and fair manner," as having "a calm and steady presence that comes from years of experience in commercial law," as having "the perfect way of bringing opinion together on arbitration tribunals," and as "understand[ing] complex legal and factual issues, distill[ing] them to their essence and then issu[ing] rulings laying out his reasoning in a convincing fashion." Glenn has been admitted to the arbitrator rosters of most major arbitral institutions. His experience as an arbitrator spans a wide range of arbitral rules and industries – including healthcare, aviation, pharmaceuticals, global logistics, insurance, software, manufacturing, transportation, IT network solutions, web domains, entertainment, hospitality, beverage, and bitcoin, among others.

He has held numerous leadership positions in the legal field, including chair of an AmLaw 200 law firm (Arnall Golden Gregory LLP), chair of the International Law Section of the American Bar Association, and founding president of the Atlanta International Arbitration Society (AtlAS). He is the immediate past president of the Georgia Arbitrators Forum (an invitation-only group of leading arbitrators in the state), a fellow of the peer-

vetted College of Commercial Arbitrators, a fellow of the Chartered Institute of Arbitrators and chair of its Southeast U.S. chapter, and the immediate past chair of the Review Board for the AHLA Dispute Resolution Service, which rules on petitions to remove arbitrators..

During the time he was still actively engaged in practicing law, the *Chambers* guide described Glenn as “an outstanding lawyer” (2015), as “a thorough business advisor able to break down complex legal matters for non-lawyers” (2017), and as “a hugely respected litigator with an impressive track record in complex cross-border business disputes and federal False Claims Act litigation” (2019). He is recognized by *Best Lawyers in America* in the fields of commercial litigation, international commercial arbitration, and healthcare law. He has received *Best Lawyers*’ Atlanta “Lawyer of the Year” award for international commercial arbitration three times (including the current year) and for healthcare law twice (including this past year) – an honor based on peer feedback conferred on only a single individual in a given geographic region.
